Preface

Hahn Air Lines GmbH is organising the “Celebrate the Africa Cup with Hahn Air and win a flight voucher” Competition from June 21st until July 19th 2019, 12:00 (GMT). Travel Agencies can participate in the competition and can win a prize according to these Terms and Conditions of Participation.

I. Organiser

The “Celebrate the Africa Cup with Hahn Air and win a flight voucher” is organised by Hahn Air Lines GmbH, An der Trift 65, D-63303 Dreieich, Germany (Hereinafter: Hahn Air Lines). II. Participation

The “Celebrate the Africa Cup with Hahn Air and win a flight voucher” and your participation in it are subject to the present Terms and Conditions of Participation. By participating in the “Celebrate the Africa Cup with Hahn Air and win a flight voucher”, you acknowledge and accept the Terms and Conditions of Participation and that these are binding.

Participation in the “Celebrate the Africa Cup with Hahn Air and win a flight voucher” is open to Travel Agencies who accepted the Terms and Conditions of Participation. Only employees of these travel agencies, who are of legal age may participate in the drawing.

In order to participate in the draw, you need to log in at www.hahnair.com and complete our “Celebrate the Africa Cup with Hahn Air and win a flight voucher”. The competition “Celebrate the Africa Cup with Hahn Air and win a flight voucher” will take place in cooperation with Kicktipp, Königstraße 9, 40212 Düsseldorf.

During the competition, you have the opportunity to predict the results of each match and get points for correct predictions. The scoring system and explanation of the competition rules you will find in the section “Game Rules”.

Upon completion of the quiz, you need to click on the submit button to transfer your personal data, thereby automatically agreeing to our Terms and Conditions of Participation and participate in the drawing.

This “Celebrate the Africa Cup with Hahn Air and win a flight voucher” is only aimed at countries under which the legislation for this raffle is legal. You declare that your participation in the “Celebrate the Africa Cup with Hahn Air and win a flight voucher” does not violate the laws of your country. If any rule or regulation of the Terms and Conditions of Participation should be or become invalid, the validity of the remaining terms and conditions shall remain unaffected.

Hahn Air Lines reserves the right to end or to suspend the “Celebrate the Africa Cup with Hahn Air and win a flight voucher” at any time without prior notice. IV. Winners, prizes, no entitlement to win, announcing the winner
